Philippe Vedrenne is appointed Chief Executive Officer of ENGIE Global Markets

The Board of Directors of ENGIE Global Markets has appointed Philippe Vedrenne as Chief Executive Officer.

This appointment has been approved by the French banking authority ACPR ("Autorité de Contrôle Prudentiel et de Résolution").

As CEO of ENGIE's regulated trading subsidiary, Philippe Vedrenne will act towards the regulator and the Board members of ENGIE Global Markets.

Philippe Vedrenne has been with the ENGIE Group since 1997 in various commercial positions. In the wake of the gas and power market liberalization, he was instrumental in setting up in 2001 Gaselys, the trading joint venture between Gaz de France and Société Générale, which later became GDF SUEZ Trading in 2011 and now ENGIE Global Markets since March 2016.

Besides his role as CEO of ENGIE Global Markets, Philippe Vedrenne keeps his current position within ENGIE "Global Energy Management" Business Unit, in charge of managing European gas midstream activities.

Philippe Vedrenne received an engineering degree from "l'Ecole des Mines de Paris" and holds an MBA from the "Collège des Ingénieurs".
